- F/14/73961 9 Whalesmead Close first floor rear extension with raised ridge height, alterations to front dormer and single storey side extension no objection to the single storey side extension but objection to the remainder of the application as the increased ridge height and proximity to rear boundary was deemed to be visually intrusive affording a view into neighbour's rear garden. If EBC was minded to permit, it might consider making the installation of opaque glazing a condition of approval. This property has already been extended at ground level and this further development would render it out of keeping with others in the area.
- C/14/73878 26 Montague Road replacement front porch objection as the proposal to have a flat roof is thought to be out of keeping; this should be an application to replace a like with like pointed roof in the conservation area
