Planning Planning Decisions report 24th June 2025

Recent Planning Decisions

H/25/99330 – 14 Torwood Gardens – Erection of first floor with associated alterations including new fenestration.

Planning Committee Decision: **Object** on the following grounds: it is not in keeping with the street scene, it may block light and possibly overlook 13 Torwood Garden and concerns raised by Southern Water regarding the proposed means of foul/surface.

Borough Council Decision: Refuse - The proposal involves the formation of a two-storey dwelling within a streetscape currently characterised by a row of modest single-storey bungalows. The proposed upward extension would appear incongruous and out of keeping with the immediate surroundings, introducing a visually intrusive dominant development that would detract from the established character and appearance of the area. As such, the proposal is contrary to Policy DM1 of the Eastleigh Borough Local Plan 2016–2036 and the guidance set out in the Quality Places Supplementary Planning Document.

T/25/99378 – 27 Sydney Road – 2no. Ash (T1 & T2, originate from Anchor Homes Land) - Reduce Southern canopy back to previous points, approximately <2m with cut size sizes no greater than 50mm. Tree has been reduced in 2019, the works are to remove the new growth back to the historic pruning sites. These works are part of ongoing maintenance to the trees, to reduce excessive bird fouling on driveway, footpath, garden & maintain adequate distance from property.

Planning Committee Decision: Raise No Objection.

Borough Council Decision: N/A – withdrawn by the applicant.
