170 Consideration of Planning Applications

170.1 H/19/87109 – 57 Stoke Park Road – Loft conversion to provide first floor living accommodation with 8no. rooflights – The Committee agreed to raise no objection to this application but to comment that they would like to see the rear garden utilised for parking.

170.2 F/19/86348 – 58-64 Stoke Common Road – Construction of 4No. three bedroom detached chalet dwellings, 4No. four bedroom detached dwellings and 2No. three bedroom semi-detached dwellings with ancillary parking, amenity space and landscaping following demolition of Nos.58-64 Stoke Common Road (Amended) – The Committee agreed to object on the grounds that there is no provision for affordable / social housing; there has been no significant change to the design of the properties so they are still not in keeping with the local area; there is an unmet requirement for visitor

parking; this development would mean the loss of several bungalows for the elderly with no similar new provision and as there is still no public transport in the area the significant increase in traffic movements in an already hazardous location will prove dangerous.

To agree a response, if needed, to the proposed Traffic Regulation Order for roads in Bishopstoke

171.1 The proposed TROs for Bishopstoke had been circulated with the documents for this meeting.

171.2 The Committee agreed that the proposals for Fox Close and for Truro Rise were sensible. In discussion regarding the Church Road proposals it was agreed that whilst these plans are an improvement, they will still have the effect of pushing problem parking onto surrounding roads. In particular, the Committee agreed to request that the blue dotted line have its restrictions lifted at 6pm not 8pm. The Committee also wished to request that the layby opposite have its restrictions amended to finish at 6pm. The Committee strongly believe that as a result of these changes there will be more parking on Spring Lane which will prove significantly hazardous due to the layout of the road.
